Public Comment

Representatives from Boy Scout Troop #625 were present, and asked about the duties of the Township Supervisors. Chairman Boni explained that the Supervisors are responsible for maintaining the roads, alleys, culverts and bridges throughout the Township, including paving and snow removal. The Township also has three parks that are maintained. The Supervisors enact ordinances and resolutions setting rules and regulations for various activities within the Township. The representative asked if the Supervisors were paid, and Mr. Boni replied that under Pennsylvania law, Supervisors in this size Township receive \$150 per month. Some Supervisors may also work as Township employees, such as the Roadmaster, and his salary is set by the elected Auditors.

Dave Baker of 120 Cemetery Road Extension asked if there were regulations concerning dogs that bark throughout the night, and Chairman Boni said it would be unenforceable. Mr. Baker also stated that a junk truck had been removed from a neighboring property, but the trailer is still there.

Rita Davis of 1485 Banning Road asked if there was any chance of getting water on Banning Hill, and Chairman Boni said funding is almost impossible to get, and recalled that a majority of the residents surveyed a couple years ago had indicated that they did not want water.
